A RESOLUTION APPROVING THE ISSUANCE OF A RETAILER'S ALCOHOLIC LIQUOR LICENSE FOR PROPERTY SITUATED AT 530 NE HWY 400 CHEROKEE

WHEREAS, K.S.A. 19-101 et. seq., and K.S.A. 19-212 authorize the Board of County Commissioners to transact all County business and perform all powers of local legislation deemed appropriate, and to make all contracts and do all other acts in relation to the property and concerns of the county, necessary to the exercise of its corporate or administrative powers; and
