Commissioner Frazier moved to reimburse K Camp \$1225 for legal fees in case number PPSU2019011780. Commissioner Moates 2<sup>nd</sup>, motion passed. 3-0.

Commissioner Moates moved to approve the Baxter Springs Police Chief's request for permission to install a light bar on Seth Brown's 2005 Lincoln Navigator to be used by the Baxter Police and Fire Department. Commissioner Anderson 2<sup>nd</sup>, motion passed 3-0.

Commissioner Frazier Moved to allocate \$3340 for 1 business and food pantries from the CDBG funds. Commissioner Moates 2<sup>nd</sup>, motion passed 3-0.

Commissioner Moates moved to adjourn until the next regular session November 2<sup>nd</sup> 2020, Commissioner Anderson 2<sup>nd</sup> the motion, motion passed 3-0. Meeting adjourned at 11:23.
