Dale Helwig and Christina Holmes invited THE BOARD to the K STATE Extension annual banquet to be held at 4-H building Columbus, Kansas November 5, 2020.

Cherokee County Health Department head Betha Elliot reported on SPARKS funding, testing, contract tracing, and vaccines.

Commissioner Frazier moved to break at 1:02 p.m. and to reconvene at 1:45 p.m. Commissioner Anderson 2nd, motion passed 3-0. Meeting reconvened at 1:43 p.m.

Commissioner Frazier moved to go into executive session at 1:45 p.m. with non-elect County Counselor Barbara Wright, Road & Bridge employees Leonard Vanatta and Joni Hicks, and applicant Cody Zook for follow up interview, and to reconvene at 2:00 p.m. Meeting reconvened at 2:00 p.m. No action taken.

Commissioner Frazier moved to hire Cody Zook as assistant Road & Bridge Supervisor starting November 2, 2020 at a prorated salary of \$45,000 yearly. Then start as Road & Bridge Supervisor January 1, 2021 at

a yearly salary of \$50,000 for a 90- day probation period. Then \$52,000 yearly after probation. Commissioner Moates 2^{nd} , motion passed 3-0.

Commissioner Frazier moved to increase the hourly wage for Joni Hicks from \$14.25 to \$15.50. Commissioner Moates 2^{nd} , motion Passed 3-0.

Commissioner Frazier moved to adjourn until the next regular session Monday October 26, 2020. Commissioner Anderson 2^{nd} the motion, motion passed 3-0. Meeting adjourned at 2:04.
