MINUTES for May 9, 2022 BOARD of CHEROKEE COUNTY COMMISSIONERS' CHEROKEE COUNTY, KANSAS

CONVENE

Chairman Cory Moates called the regular session of the Cherokee County Board of Commissioners (The Board), to order at 9:00 AM on Monday, May 9, 2022, in the Commission Room, #109 of the Cherokee County Courthouse located at 110 W Maple St., Columbus, Kansas. County Commissioner Cory Moates opened the meeting with prayer followed by the Pledge Allegiance. Commissioners Cory Moates, Lorie Johnson, Myra Frazier, County Clerk Rebecca Brassart, County Counselor Nathan Coleman, Road and Bridge Supervisor Cody Zook, News Report owner Larry Hight and Columbus News reporter Jacob Spencer were present.

APPROVAL of MINUTES

A motion was made by Commissioner Frazier to approve the minutes of the May 2, 2022, meeting as written. The motion was seconded by Commissioner Johnson. The motion passed unanimously with Commissioner Moates abstaining due to not being present for the May 2, 2022, meeting.

ROAD & BRIDGE
