MINUTES FOR APRIL 20, 2015

BOARD OF CHEROKEE COUNTY COMMISSIONERS

CHEROKEE COUNTY, KANSAS

CONVENE

Commissioner Hilderbrand called the regular session of the Cherokee County Board of Commissioners (The Board), to order and led all in attendance in the Pledge of Allegiance at 9:00 AM on Monday, April 20, 2015 in the Commission Room, #109 of the Cherokee County Courthouse located at 110 W Maple St., Columbus, Kansas. Commissioners Richard Hilderbrand, Charles Napier, Pat Collins, and County Clerk Rodney Edmondson were present.

A motion was made by Commissioner Collins to approve the Minutes of the BOCC Meeting for April 13, 2015. The motion was seconded by Commissioner Napier. The motion carried 3-0.

A motion was made by Commissioner Collins to approve the Payroll for the month of April, 2015. The motion was seconded by Commissioner Napier. The motion carried 3-0.

A motion was made by Commissioner Collins to approve the Accounts Payables for the month of April, 2015. The motion was seconded by Commissioner Napier. The motion carried 3-0.

A motion was made by Commissioner Collins pursuant to K.S.A. 79-1701a to approve one clerical error in the valuation of a property located at 4950 SE 118th St. owned by Claire E. Moore as recommended by the appraisers office. The motion was seconded by Commissioner Napier. The motion carried 3-0.

W.E. Schaiff appeared before the Board concerning the election contest that has been filed in the District Court concerning Ward 4 in Columbus. He feels the County Clerk should pay the \$195 that the candidate was forced to pay to the District Court. Clerk Edmondson stated that he was doing what the Secretary of State's Office and legal counsel instructed him to do and that there was nothing he could do to correct the mistake at the polling place, it was human error.

A motion was made by Commissioner Collins to give a \$25 Wal-Mart gift card to any employee that participates in the health screenings for the first time, or any employee that made improvement or stayed the same from last year's screenings. The motion was seconded by Commissioner Napier. The motion carried 3-0.

Property Tax Relief Applications - Baxter Springs Tornado

The Board reviewed Property Tax Relief Applications for consideration of tax abatements to homesteads damaged as a result of the tornado in Baxter Springs on April 27, 2014.

The Board reviewed the following application and made determinations as indicated.

Elanor Myers, 524 E 13th St. – A motion was made by Commissioner Hilderbrand, seconded by Commissioner Napier to deny any relief based on the fact that damage was only 16% of the value of the structure. The motion carried 3-0. The minimum is 50% damage to qualify for any relief.



Students and faculty from USD 247 appeared before the Board to present them with a thank you banner for their donation to the safe room project at the school in Weir.

Leonard Vanatta - County Road Supervisor Gene Langerot - County Lot Supervisor

They appeared before the Board on routine county road business.

A motion was made by Commissioner Napier to enter an Executive Session with the Board, Gene Langerot, and Leonard Vanatta for a period of 10 minutes for the purpose of Non/Elected personnel. The motion was seconded by Commissioner Collins. The motion carried 3-0 at 9:28 AM.

The meeting reconvened at 9:38 AM.

No action was taken during the Executive Session.

A motion was made by Commissioner Hilderbrand to amend the agenda from 10:45 AM to 10:34 AM for Jean Pritchett. The motion was seconded by Commissioner Napier. The motion carried 3-0.

Jean Pritchett - Columbus Chamber of Commerce

She appeared before the Board to present two applications for tourism grants. The Galena Volunteer Fire Department is requesting \$300 for Galena Days Celebration. The Columbus Cal Ripken Baseball Association is requesting \$300 for the Cal Ripken State Baseball Tournament.

A motion was made by Commissioner Hilderbrand to approve both grant requests. The motion was seconded by Commissioner Napier. The motion carried 3-0.

Mac Young - Community Corrections

He appeared before the Board seeking approval of the 2016 Comprehensive Plan and Budget for the 11th Judicial District Community Corrections.

He reported that there are no changes to the core programs for 2016. The budget for 2016 is \$511,135, a reduction from the 2015 budget of \$535,383. He stated that the legislative session is not complete and more cuts could come.

A motion was made by Commissioner Collins to accept the 2016 Comprehensive Plan for Community Corrections as presented by Mac Young. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes. Chairman Hilderbrand signed the agreement.

A completed agreement will be returned when all counties have signed.

A motion was made by Commissioner Hilderbrand to amend the agenda from 11:30 AM to 11:11 AM for Nathan Coleman. The motion was seconded by Commissioner Napier. The motion carried 3-0.

Nathan Coleman - County Counselor

He appeared before the Board regarding legal matters concerning Cherokee County.



He updated the Board on Dustin Bronson's request for a family cemetery. Mr. Bronson was unable to appear today, so it has been continued to next week. He stated that the county approved a similar request in 2006 and stated at that time no county prohibitions against it existed.

He reported that the election contest over the Columbus Ward 4 issue is now in the hands of the District Court.

Commissioner Hilderbrand made a motion to adjourn until the next regularly scheduled meeting set for April 27, 2015 at 9:00 AM. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes at 11:35 AM.
