MINUTES FOR JULY 30, 2012

The Cherokee County Commissioners met July 30, 2012. Those in attendance were Commissioners Collins, Garner, and Hilderbrand. The Pledge of Allegiance was said by all. Commissioner Hilderbrand made a motion to accept the commission amended minutes for July 23, 2012; his motion was seconded by Commissioner Garner with Commissioners Collins, Garner, and Hilderbrand voting in favor. Those signing off on the commission amended minutes were Commissioners Hilderbrand, Collins and Garner, and County Clerk Crystal Gatewood.

MOTIONS MADE BY COMMISSION

Commissioner Garner made a motion to move Shawn Turner from 10:30 AM to 10:22 AM on the agenda; his motion was seconded by Commissioner Collins with Commissioners Hilderbrand, Collins, and Garner voting in favor.

Shawn Turner, representing the Riverton Sewer District, submitted the lowest bid for the project in the amount of \$273,841.00 from Warstler Excavating, and he also recommended the commission amend their bid loan. Commissioner Garner made a motion, pending KDHE approval, and with the recommendation of Shawn Turner to approve the Warstler bid of \$273,841.00 for the Riverton Sewer systems; his motion was seconded by Commissioner Hilderbrand with Commissioners Garner, Collins, and Hilderbrand voting in favor. Shawn will return on Monday, August 6, 2012 at 10:30 AM with the figures that will be needed to amend their bid loan. (A copy of the bids is attached to these minutes.)

OTHER BUSINESS

Leonard Vanatta, Supervisor of the Road and Bridge Department, reported Weaver Bridge should be completed this week and that in September the county will be seeding the area with native grasses. He also said they will be hauling dirt on Tuesday for the museum project and they also will be bringing in clay, and that will take a couple of days. They discussed area railroad crossings and Commissioner Collins said there were about five that needed attention here in the county, and he did not understand why the railroad will not take care of them.

Katy Parker, representing the Family Peace Initiative, which is a domestic battery program that started back in 1992, came before the commission. The program needs \$50,000.00 to operate for a year and they are asking commissioners in Cherokee, Crawford, Bourbon, and Labette counties to donate \$12,500.00 from each of the counties. Ms. Parker asked if the commission would be able to meet with the other counties to see if this would be something they all wanted to fund so the service is available. The commission recommended she get with the two County Attorney Candidates on the November General Election and discuss it with them, and Commissioner Hilderbrand asked Commissioner Collins to meet with the group when the meeting was scheduled. She agreed to make sure he knew when the meeting was scheduled. The commission thanked her for coming in.

Election Officer Crystal Gatewood reported that she held poll worker training on July 24, 2012 and July 26, 2012 here at the courthouse in the break room for all poll workers who will be working at the August 7, 2012 Primary Election polling places in the county. She said the training went very well and everyone is ready. Open voting ends August 6, 2012 at noon.



To Whom it May Concern:

I am writing as not only a concerned citizen, but one who has worked with the Safehouse Crisis Center, Inc. (Safehouse), in various capacities since 1992. Safehouse developed one of the first batterer's intervention programs in the state in 1992. This program, now known as the Family Peace Initiative (FPI) has been a part of Southeast Kansas Independent Living (SKIL) for five years. While the work of the FPI is not centrally related to the mission of SKIL, at the time, the administrators of SKIL recognized the need of this program in our community and agreed to provide space and money to ensure that men (and women) in our community who use abusive and violent tactics in their relationship are held accountable and provided alternative tools that will not only prevent them from using such tactics in the future, but will be able to have healthier relationships with their partners, children, and with those in the community. It is my understanding that their support is, unfortunately, no longer possible.

I have been working in many capacities on the issue of domestic violence and sexual assault since 1986. The most relevant of these include serving as a co-facilitator of the Alternatives to Battering program (now known as FPI) for five years, professional (academic) expertise in the area of domestic violence and sexual assault, and my current service as a member of the Kansas State's Batterer's Intervention Program Certification Board for the Kansas State Attorney General's Office.

Our communities in Southeast Kansas are at risk of losing the FPI program. I urge you to consider providing support for FPI, in order for the organization to have time to more clearly develop and implement a plan to become financially independent. Without support, momentum that has been gained by this program will be reduced, and the chances of its success are drastically reduced. With support and some time, this program could become fiscally independent. Beyond that, and more importantly, individuals and families in SEK will be safer. Obviously, a safer community has direct ramifications for the emotional, psychological, physical, and financial well being of its citizens.

For the sake of simplicity, I will highlight the following points:

- The "typical" batterer does not stop battering without intervention. Supporting a victim of
 abuse does help that particular victim, but the statistics---and my experience working as a
 volunteer for Safehouse---indicates that while one victim may be "saved," another one is
 successfully targeted as a victim by the same batterer.
- Intervention is critical to stop the aforementioned pattern of a batterer.
- FPI, which serves SEK, is currently one of the strongest programs in the state. It was the first in the state to be certified by the Kansas Attorney General's office, with no identified proficiencies.
- The state legislature recently passed legislation which recognizes the need and essentiality of batterer's intervention programs (BIP). Hence, communities that do not have certified BIP services available for those who are arrested for domestic violence crimes are not in compliance with the law.
- Currently, batterer's intervention programs (BIP) all across the state are rushing to ensure that
 they have certified BIP programs that not only provide services which are so essential, but are in
 compliance with the law.

These, together, serve as a foundation for the most obvious reason to support the FPI:

- The need in SEK for this service is paramount.
- Victims and their families, including children in SEK, will be at increased risk of abuse of all kinds, violent assaults, and even the possibility of homicide if batterers are not held accountable for their actions
- Providing support to FPI so that its services can be sustained is the right thing to do.
