Commissioner Anderson moved to accept and approve the June 1, 2020 minutes. Commissioner Frazier 2<sup>nd</sup>, motion passed 3-0.

Commissioner Frazier moved to approve the 2021 Community Corrections budget plan. Commissioner Anderson 2<sup>nd</sup>, motion passed.3-0.

Commissioner Frazier moved to appoint Misty Moore as Treasurer for Shawnee Township. Commissioner Anderson 2<sup>nd</sup>, motion passed 3-0.

Commissioner Frazier moved to add Betty Morgan and Sue Proffitt (employees of the County Clerks Department) as signatories on the American Bank account. Commissioner Moates 2<sup>nd</sup>, motion passed 3-0.

Deana Randall, HR Department, presented her 2021 budget request. The Board took it under advisement.

Cherokee County Treasurer, Raven Elmore, presented her 2021 budget proposal. The Board took it under advisement.

Commissioner Frazier moved to exempt the CDBG-CV Grant from Government Environmental Review. Commissioner Moates 2<sup>nd</sup>, motion passed 3-0.

Commissioner Moates moved to accept the CDBG-CV contract. Commissioner Anderson 2<sup>nd</sup>, motion passed 3-0.

Janet Miller, Economic Director, drafted a letter acknowledging the nomination of Historic Route 66 as an All American Road. The nomination was made by the Kansas Historic Byway Nominating Committee.

David Holmes, Carla Karsten, and Dale Helwig, presented the 2021Cherokee County Extension Council Budget. The Board took it under advisement.

Commissioner Frazier moved to approve and sign a contract to hire Cecil Brown as temporary Noxious Weed department employee. Commissioner Moates 2<sup>nd</sup>, motion passed 3-0.

County Attorney, Jacob Conard presented his 2021 budget proposal. Request was taken under advisement by the Board.

Commissioner Anderson moved to hire Taylor Brown at \$15.60 an hour in the Appraiser's Office, employment starting June 29, 2020. Commissioner Moates 2<sup>nd</sup>, motion passed 3-0.

Commissioner Frazier moved to adjourn until 1:00 p.m. Commissioner Anderson 2<sup>nd</sup>, motion passed 3-0.

Sheriff Groves updated THE BOARD on COVID-19 cases for surrounding counties, 1 in Montgomery, 4 in Labette, 1 in Cherokee, and 1 in Crawford.

Sheriff David Groves presented his 2021 budget proposal. Proposal was under advisement by the Board.
