Commissioners Pat Collins, Neal Anderson, Cory Moates, County Counselor Barbara Wright, and County Clerk Rodney Edmondson were present.

Raven Elmore, Cherokee County Treasurer, presented a revised agreement from DeAnn Hill for the work to be done in the Treasurer's Office for the balancing of the bank accounts for the Board to review. He stated that due to the size of the job, he doesn't feel the need to get more bids. He plans to use diversion application funds for the project. The Board approved the expenditure.
