### **MINUTES FOR JANUARY 21, 2014**

### **BOARD OF CHEROKEE COUNTY COMMISSIONERS**

### **CONVENE**

Commissioner Hilderbrand called the regular session of the Cherokee County Board of Commissioners (The Board), to order at 9:00 AM on Tuesday, January 21, 2014 in the Commission Room, #109 of the Cherokee County Courthouse located at 110 W Maple St., Columbus, Kansas. Commissioners Richard Hilderbrand, Charles Napier, Pat Collins, and County Clerk Rodney Edmondson were present.

### David Eddington - Cal Ripkin State Baseball Tournament

He appeared before the Board to announce that Columbus will be hosting the 12 and Under Cal Ripkin State Baseball Tournament July 9-13, 2014. The Columbus Cal Ripkin Program is just now beginning to raise funds to host the tournament. He provided a written plan of events for the tournament. The Board took the proposal under advisement.

### Leonard Vanatta - County Road Supervisor Gene Langerot - County Lot Supervisor

They appeared before the Board on routine county road business. They provided an estimate from Wisdom's Pump Service to upgrade the fuel pumps at the lot. Leonard advised that the bridge project on U166 should be finished in mid to late March according to KDOT.

A motion was made by Commissioner Collins to purchase the fuel distribution pumps and card readers from Wisdom's Pump Service Inc. at a cost of \$53,487 payable in 1/3 payments as agreed. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

A motion was made by Commissioner Collins to approve the Minutes of the January 13, 2014 BOCC Meeting as written. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

A motion was made by Commissioner Collins to approve Payroll for January, 2014. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

A motion was made by Commissioner Napier to approve the Accounts Payables for January, 2014. The motion was seconded by Commissioner Collins. The motion carried 3-0 with all voting yes.

### Reorganization:

Commissioner Collins made a motion to elect Commissioner Hilderbrand the Board Chair for 2014. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

Commissioner Napier made a motion to elect Commissioner Collins the Board Vice-Chair for 2014. The motion was seconded by Commissioner Hilderbrand. The motion carried 3-0 with all voting yes.



Commissioner Hilderbrand made a motion to designate the American Bank of Baxter Springs, Columbus, and Galena as the official working bank for Cherokee County for 2014, with all other banks to be recognized as depositories. The motion was seconded by Commissioner Collins. The motion carried 3-0 with all voting yes.

Commissioner Napier made a motion to designate the Columbus News Report as the Official County Newspaper for 2014. Commissioner Hilderbrand recommended that we continue the annual rotation basis with the Cherokee County News Advocate being up next. Commissioner Napier rescinded his motion. The Board will discuss the item with Mr. Cure and tabled the item until further notice. The Galena Sentinel will remain the Official County Newspaper until such time that another newspaper is named.

Commissioner Collins made a motion to appoint Kevin Cure as the Legal Counselor to the Board of Cherokee County Commissioners for 2014. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

Commissioner Collins made a motion to appoint Leonard Vanatta as the Cherokee County Road & Bridge Supervisor and Gene Langerot as the Cherokee County Lot Supervisor for 2014. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

Commissioner Collins made a motion to appoint Jason Allison as the Emergency Preparedness Director for Cherokee County for 2014. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

Commissioner Hilderbrand made a motion to appoint Betha Elliott as the Director of the Cherokee County Health Department for 2014. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

Commissioner Napier made a motion to appoint Mense, Churchwell, and Mense as the Official Auditing Firm for Cherokee County for 2014. The motion was seconded by Commissioner Collins. The motion carried 3-0 with all voting yes.

A motion was made by Commissioner Collins to appoint Melanie Bingham, Sam Marsh, Candace Gayoso, and Kevin Cure as Court Appointed Counsels for the District Court. The motion was seconded by Commissioner Napier. The motion carried 3-0.

### **Kevin Cure - County Counselor**

He appeared before the Board on legal matters concerning Cherokee County. He presented a Resolution conveying county owned land to the Board for consideration.

A motion was made by Commissioner Collins to pass Resolution 03-2014 conveying county owned land to Galena Liberty Hall, LLC. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

A motion was made by Commissioner Collins to have Chairman Hilderbrand sign and execute a Quitclaim Deed to Galena Liberty Hall, LLC in response to Resolution 03-2014. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.



A motion was made by Commissioner Hilderbrand to sign the 2014 agreement with Class LTD for Mental Retardation Services for Cherokee County. The motion was seconded by Commissioner Collins. The motion carried 3-0 with all voting yes.

Commissioner Collins has viewed the property at 604 N Hill St. in Scammon. It's a vacant lot that is ready to have a house built on it. He advised that the City of Scammon would accept the property from the County if they acquire it from Wells Fargo. The Board asked Counselor Kevin Cure to notify Wells Fargo that they will accept the property and to prepare a Deed to transfer the property from Cherokee County to the City of Scammon once the property is owned by the County.

A motion was made by Commissioner Collins to appoint Commissioner Hilderbrand to a one year term to the Shoal Creek Basin Regional Wastewater Authority. The term is from December 1 through Nov 30, 2014. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

A motion was made by Commissioner Hilderbrand to appoint Commissioner Collins as Cherokee County's representative to the SEK Regional Juvenile Detention Center Board of Directors. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

A motion was made by Commissioner Collins to approve Resolution 04-2014 urging the Kansas Legislature and Governor Sam Brownback to retain the mortgage registration fee, and reject any or all legislative proposals abolishing such fee. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

The Board discussed the options when appointing an Official County Newspaper. Counselor Kevin Cure advised that he will research the topic and report on it next Monday.

Commissioner Hilderbrand made a motion to adjourn until the next regularly scheduled meeting set for Monday, January 27, 2014 at 9:00 AM. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes at 11:51 AM.

# RESOLUTION NO. 3 - 2014

# RESOLUTION NO. 4 - 204

A resolution of the Board of Cherokee County Commissioners urging the Kansas Legislature and Governor Sam Brownback to retain the mortgage registration fee, as provided in K.S.A. 79-3102, and reject any or all legislative proposals abolishing such fee.

Whereas, in 1925, the Kansas Legislature enacted a law (K.S.A. 79-3102) providing that, before any mortgage of real property is filed with the County Register of Deeds, the individual or entity filing the mortgage pay a mortgage registration fee; and

Whereas, the Legislature has revisited the policy of the mortgage registration fee and enacted changes thereto on various occasions since 1925;

Whereas, the current fee is a one-time payment of 0.26% of the principal debt securing the mortgage; and

Whereas, the process of recording mortgages with the Register of Deeds is an important county function to ensure free and clear transactions involving land deals, giving potential landowners assurance that a property is unencumbered by liens; and

Whereas, a mortgage is enforceable only upon payment of the mortgage registration fee; and

Whereas, the 25/26<sup>th</sup> of the mortgage registration fee is deposited in a county's general fund, where it is used to finance basic operations of county government and 1/26<sup>th</sup> of the fee is remitted to the State Treasurer to finance the Heritage Trust Fund which helps preserve historic structures.

Now, therefore, be it resolved, by the Board of County Commissioners (Supervisors) of Cherokee County, Kansas, that the mortgage registration fee is an important revenue source for counties, and is one of a very few revenue streams counties have to finance essential county services; and

Be it further resolved that, in the budget years 2010, 2011, and 2012, Cherokee County received and deposited \$\_144,332.23 \$\_111,878.73 and \$\_\_157,250.65 from the mortgage registration fee in the general fund, respectively; and that absent such fees and no change in county services, county property taxpayers would have experienced increased mill levies of 1.0mill(s); .77(mill(s); and 1.13 mill(s), in 2010, 2011 and 2012, respectively; and

Be it further resolved that it would be profoundly unfair to counties and most of all, county property taxpayers in general, for counties to lose the revenue generated by the mortgage registration fee without the Legislature identifying and authorizing a revenue measure of equal or greater significance; and

Be it further resolved that in the absence of an identified, authorized substitute revenue source, that we urge the Kansas Legislature and Governor Sam Brownback to retain the current mortgage

registration fee, as provided in K.S.A. 79-3102, and reject any or all legislative proposals abolishing such fee; and

**Be it further resolved** that a copy of this resolution be sent to members of the Kansas Senate and House of Representatives representing this county; to Governor Sam Brownback; to all newspapers, radio and television stations serving this county; and to the Kansas Association of Counties.
