Commissioner Garner made a motion to approve the commission minutes for November 5, 2012 as presented by County Clerk Crystal Gatewood; his motion was seconded by Commissioner Collins with Commissioners Garner, Hilderbrand, and Collins voting in favor. Commissioners Garner, Hilderbrand and Collins, and County Clerk Gatewood signed off on the minutes.

MOTIONS MADE BY COMMISSION

Commissioner Collins made a motion to approve and pay November Mid-Month Accounts Payables as presented; his motion was seconded by Commissioner Garner with Commissioners Collins, Garner, and Hilderbrand voting in favor.

Upon a motion by Commissioner Garner with a second by Commissioner Collins, and a vote of the full membership of the Cherokee County Board of Commissioners of Cherokee County, Kansas, thereon of three in approval and none opposed, the results of the General Election held November 6, 2012 are certified as accurate and true after the canvassing of the results. The board of Cherokee County Commissioners consisting of Commissioners Jack Garner, Pat Collins and Richard Hilderbrand, and under the consultation of County Counselor Kevin Cure, have determined that 331 Provisional Ballots were deemed reviewed. The final results were; of the Provisionals presented; 5 partial ballots, 172 ballots counted and 154 ballots were not deemed qualified after further review by the Cherokee County Commissioners. Commissioners Garner, Collins, and Hilderbrand voted in favor of the results. Commissioners Hilderbrand, Collins and Garner, County Clerk Crystal Gatewood, Deputy County Clerk Paula Cheney, and County Counselor Cure signed off on the official documentation. The approved Provisionals by the Cherokee County Canvassing Board were added to the vote count in their respective precinct in Cherokee County by Cherokee County Election Officer Crystal Gatewood on November 12, 2012. The document containing the final results was then submitted to the commission on Monday, November 12, 2012 for signatures by the Cherokee County Board of County Commissioners and County Counselor Cure. County Counselor Kevin Cure had John Guttierez from the Cherokee County Attorney's Office in attendance to provide legal counsel to the commission for the special re-call election of the city councilmen in Baxter Springs, Kansas because of a conflict of interest on his behalf.
