Courthouse Maintenance: Ralph Houser reported on the on-going repairs on the exterior of the courthouse.

Cherokee County resident Royce Cantrell addressed THE BOARD, asking for direction and help in an on-going issue on property he owns with sewage draining onto his property and other problems in the Galena area.
