MINUTES for June 13, 2022

BOARD of CHEROKEE COUNTY COMMISSIONERS'
CHEROKEE COUNTY, KANSAS

CONVENE

Chairman Cory Moates called the regular session of the Cherokee County Board of Commissioners (the Board), to order at 9:00 a.m. on Monday, June 13, 2022, in the Commission Room, #109 of the Cherokee County Courthouse located at 110 W Maple St., Columbus, Kansas. Commissioner Lorie Johnson opened the meeting with prayer followed by the Pledge of Allegiance. Commissioners Cory Moates, Lorie Johnson, Myra Frazier, County Clerk Rebecca Brassart, Cody Zook and Bryan Williams with Road and Bridge, Jim Burton with Solid Waste committee and Larry Hight Columbus News Report owner were present.

APPROVAL of MINUTES

A motion was made by Commissioner Moates to approve the minutes of the June 6, 2022, meeting as written. The motion was seconded by Commissioner Frazier. The motion passed unanimously with Commissioner Johnson abstaining.

APPROVAL of PAYROLL

Commissioner Moates made a motion to approve the payroll as presented. Commissioner Johnson seconded the motion. The motion passed unanimously.

APPROVAL of PAYABLES

Commissioner Moates made a motion to approve the accounts payable as presented. Commissioner Johnson seconded the motion. The motion passed unanimously.

JIM BURTON SOLID WASTE

Jim Burton came before the Board to present the solid waste budget.

CODY ZOOK & BRYAN WILLIAMS ROAD & BRIDGE

Cody Zook and Bryan Williams came before the Board for the County Road and bridge department. Cody opened the discussion requesting for the Board to approve the new hire of summer help. Commissioner Moates made a motion to approve the hiring of Walker Terry at \$12.00 an hour as a temporary labor for road and bridge. Commissioner Johnson seconded the motion. The motion passed unanimously.

Cody discussed the ROW (Right-a-way) example plans with the Board. County Counselor Nathan Coleman stated that the Wichita attorney is working on the ROW plan.

Zook informed the Board of the options in the grader and equipment plan. Discussion was had between the Board and Cody regarding the plan. The Board stated that they were very happy with the amount of time that was spent to make a long-term plan regarding the graders. Commissioner Moates made a motion to approve the paperwork for the 10 graders along with additional equipment and a routine service maintenance plan for the road and bridge. Commissioner Johnson seconded the motion. The motion passed unanimously.

Maintenance coordinator Chris Johnson came before the Board to discuss the possibility of placing security cameras at all entry doors of the courthouse.
