Minutes for August 17, 2020 Cherokee County Commissioners Cherokee County Kansas

Chairperson Frazier called the regular session meeting of the Cherokee County Commissioners to order at 9:00 a.m. Monday August 17,2020 in room #34 of the Cherokee County Courthouse located at 110 West Maple, Columbus, Kansas. Commissioner Frazier opened with prayer and the Pledge of Allegiance.

Commissioners Myra Frazier, Neal Anderson, Cory Moates. County Counselor Barbara Wright, and County Clerk, Kyle Rennie were present. Larry Hiatt member of the press also present.

Commissioner Moates moved to accept and approve the August 10, 2020 minutes. Commissioner Anderson 2nd, motion passed 3-0.

Discussion was held on Track hoe accident. The incident happened August 12,2020. Location was located from junction 7 & 69 highways, 7 miles west on 160, then 1 mile north on 70th, ¾ mile west on Bethlehem Road on the North side in Cherry Creek.

Commissioner Frazier moved to give \$200 (for new boots) to all who were in the water working at Cherry Creek trying to secure the track hoe. Commissioner Anderson 2nd, motion passed 3-0.

Commissioner Frazier moved to go into executive session at 9:09 a.m. with non-elect personnel County Counselor Barbara Wright and R&B Supervisor Leonard Vanatta for discipline and to reconvene at 9:28 a.m. Commissioner Moates 2nd, motion passed 3-0. Meeting reconvened at 9:28 a.m. No action taken.

On August 17^h 2020 at 9:30 a.m. The Cherokee County Board of Commissioners became The Cherokee County Canvass Board. Cherokee County Clerk, Kyle Rennie and Deputy Clerk, Paula Cheney reported to the Canvass Board for official cavass of the August 3, 2020 primary election, there were 100 provisional ballots, 48 for recommendation to be counted and 52 not to be counted.

Commissioner Moates moved to accept the Election Officials recommendation to count the 48 provisional ballots and reject 52. Commissioner Anderson 2^{nd} , motion passed 3-0.

All in attendance moved to County Election Officials Office to witness the counting of the 48 provisional votes and, to witness The Cherokee County Canvass Board sign the official Canvass Document making the August 3, 2020 Primary Election official.

The Cherokee County Board of Commissioners reconvened in # room34.

Jason Allison Emergency Preparedness Director recommended to THE BOARD to not renew the 6930 SE Vark RD lease.

Commissioner Frazier moved to not renew the 6930 Vark RD lease. Commissioner Moates 2nd, motion passed 3-0.

Economic Development Director Janet Miller addressed the THE BOARD asking for signatures for distribution of CDBG Grant funds in the amount of \$10,000 to go to the Los Lunas Mexican Restaurant of Columbus Kansas. Chairwoman Frazier signed the CDBG distribution grant document.

Commissioner Moates moved to enter into contract with Stronghold Data to replace the server for \$600 a month, with an installation fee of \$1200.00. Commissioner Anderson 2^{nd} , motion passed 3-0.

Ronnie and Wade Rippel both voiced their concerns about the Track hoe accident at Cherry Creek.

Commissioner Moates moved to terminate Leonard Vanatta from Cherokee County employment. Motion died from lack of second.

Commissioner Frazier moved to go into executive session at 11:11 a.m. with non-elect personnel County Counselor Barbara Wright, for discipline. And to reconvene at 11:30 a.m. Commission Moates 2nd, motion passed 3-0. Meeting reconvened at 11:30 a.m. No action taken.

Commissioner Frazier moved to break for 10 minutes. Commissioner Anderson 2nd, motion passed 3-0.

Dale Helwig and Christina Holms Administrators of the SPARK Funds reported checks would be going out soon for approved applications.

Commissioner Frazier moved to give authority to Betha Elliot to hire staff as needed and for which she has grant money. Commissioner Moates 2nd, motion passed 3-0.

Commissioner Frazier moved to break for lunch at 11:50 a.m. and to reconvene at 1:00 p.m. Commissioner Moates 2nd, motion passed 3-0. Meeting reconvened at 1:00 p.m.

Discussion was held on the sewer budget.

Commissioner Frazier moved to go into executive session at 1:10 a.m. with non-elect personnel County Counselor Barbara Wright and Louis Schriener for discipline and to reconvene at 1:35 a.m. Commissioner Moates 2nd, motion passed 3-0. No action taken.

Commissioner Frazier moved to take a 5-minute break at 1:30 p.m. Commissioner Moates 2nd, motion passed 3-0. Meeting reconvened at 1:35 p.m.

Commissioner Frazier moved to go into executive session at 1:45 with non-elect personnel County Counselor Barbara Wright and Leonard Vanatta for discipline and to reconvene at 2:15 a.m. Commissioner Anderson 2nd, motion passed 3-0. Meeting reconvened at 2:15 a.m. No action taken.

County Counselor, Barbara Wright presented a letter of resignation effective December 31, 2020 from Leonard Vanatta, Road and Bridge Supervisor for Cherokee County.

Commissioner Anderson moved to accept Leonard Vanatta's letter of resignation. Commissioner Frazier 2nd, motion passed 2-1. Commissioner Moates opposed.

Commissioner Frazier moved to adjourn until the special Sales Tax Meeting August 20, 2020. Commissioner Anderson 2^{nd} , motion passed 3-0. Meeting adjourned at 2:25 p.m.
