MINUTES FOR APRIL 8th, 2013

BOARD OF CHEROKEE COUNTY COMMISSIONERS

CHEROKEE COUNTY, KANSAS

CONVENE

Chairman Richard Hilderbrand called the regular session of the Cherokee County Board of Commissioners to order and led all in attendance in the Pledge of Allegiance at 9:00 AM on Monday, April 8th, 2013 in the Commission Room, #109 of the Cherokee County Courthouse. Commissioners Pat Collins, Charles Napier, and Richard Hilderbrand, and County Clerk Rodney Edmondson were present.

Members of the press present: Larry Hiatt, Patrick Richardson, and Machelle Smith

Visitors: Lori Johnson of the Cherokee County Republican Party

Senator Jake LaTurner came before the Board to give them a Legislative Update.

Leonard Vanatta - Road & Bridge Supervisor

Gene Langerot - Lot Supervisor

Leonard reported to the Board that it would take 560-580 tons of material on 78th St. A 2" cap of asphalt will cost approximately \$80,000 per mile. Commissioner Napier stated that he wants to overlay the three miles going to Claythorne Lodge. He is considering doing two miles this year and one mile next year.

Gene reported that Jason Allison's vehicle should be finished today.

9:30 AM - The County Board of Canvassers convened to canvass the April 2nd, 2013 City/School General Election in the Commissioners' Meeting Room.

In attendance: Commissioners; Chairman Richard Hilderbrand, Pat Collins, and Charles Napier. Rodney Edmondson, County Clerk/Election Officer; Paula Cheney, Deputy Clerk/Election Officer; Susan Jones, County Clerk's Office, to take minutes. County Attorney Nathan Coleman to oversee the counting of Baxter Springs Provisional Ballots, and County Counselor Kevin Cure. Special Election Board consisted of Shannon Perry, Ashtin McDaniel, and Vickie Winlund for the purpose of opening and counting provisional ballots.

Edmondson and Cheney presented 25 provisional ballots for consideration by the Board. 17 ballots were determined by the Board to be counted, 8 ballots were not to be counted.

10:10 AM - The canvassing moved to the Office of the County Clerk. The Board of Commissioners inspected the M-100 ballot counting machines and determined that no ballots were contained within the machines prior to inserting the ballots. The Special Board opened the 17 provisional ballots and inserted them into the machines.

10:27 AM - Canvassing returned to the Commissioners Meeting Room to review the final results of the election.

11:00 AM - A motion was made by Commissioner Napier to certify the April 2nd Election. It was seconded by Commissioner Collins. The motion carried 3-0 with all voting yes. The Official Canvass Certification Letter was signed by the Board, County Clerk, Deputy County Clerk, County Attorney, and County Counselor.

11:03 AM - A motion was made by Commissioner Hilderbrand for a 10 minute recess. It was seconded by Commissioner Collins. The motion carried 3-0 with all voting yes.

The meeting reconvened at 11:15 AM.

A motion was made by Commissioner Hilderbrand to approve the minutes of the April 1st, 2013 Commission Meeting as written. It was seconded by Commissioner Collins. The motion carried 3-0 with all voting yes.

A motion was made by Commissioner Hilderbrand to reappoint Susan Gant to be Cherokee County's representative to the 11th Judicial District Corrections Advisory Board. It was seconded by Commissioner Collins. The motion carried 3-0 with all voting yes.

The Board received from the County Clerk a copy of the resignation of Sherry Cassell and Shannon Justice from the Neosho Township Board as Clerk and Trustee respectively. Those two positions are now vacant.

David Grove, Terry Clugston - Sheriff and Undersheriff

They appeared before the Board to discuss the condition of the current patrol car fleet. The last new car was purchased in 2003, since then they have bought used vehicles. He stated that maintenance costs are quite expensive for the older used vehicles. He reported that the used car market has been exhausted and would like the Board to consider purchasing three new patrol cars, from funds other than his, to begin a rotation process that he would fund thereafter. Estimated cost of the vehicles is \$23,916 each, for a total cost estimate of \$71,748.00. After consideration the board agreed to assist.

A motion was made by Commissioner Collins to purchase three new Ford Interceptor patrol vehicles for the Sheriff's Department, to be paid for out of County General Funds. It was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

Kevin Cure - County Counselor, presented a revised resolution for the Lola Fire District to remove issues from the previously passed Resolution 06-2013.

A motion was made by Commissioner Napier to pass Resolution 09-2013. It was seconded by Commissioner Collins. The motion carried 3-0 with all voting yes.

The appointments to the Lola Fire District Board have been set up for 2 year terms, to take office in January to coincide with commissioner positions.

11:45 AM - A Public Hearing for the Gillstrap Road establishment. No one appeared in opposition.

The Public Hearing closed at 11:48 AM.

A motion was made by Commissioner Hilderbrand to pass Resolution 10-2013 to establish Gilstrap Road. It was second by Commissioner Collins. The motion carried 3-0 with all voting yes.



A motion was made by Commissioner Collins and second by Commissioner Napier to recess for lunch. The motion carried 3-0 with all voting yes at 11:55 AM.

1:04 PM - the meeting reconvened.

Auditors Gene and Matt Mense appeared at the request of the Board for further guidance on the handling of the Penn Gaming lawsuit settlement funds.

Audy Holman of Fabick Caterpillar appeared at the request of the Board to provide a detailed report of the prior payments and payoff balance of the Caterpillar motor graders on lease by the County. It was determined that the payoff balance of the graders to Caterpillar Financial is \$877,602.00 including all fees.

A motion was made by Commissioner Hilderbrand to pay Caterpillar Financial \$877,602.00 from the Penn Gaming lawsuit settlement funds. It was second by Commissioner Napier. The motion carried 3-0 with all voting yes.

Dave Malone - Jail Bond refinancing

He has reviewed the 2005 bonds for the Jail, and he stated that he can save the County some money by refinancing. If \$200,000 is taken from the jail bond reserve account that currently has a balance of \$314,000, and sales take income remains the same each month, the county can save \$520,000 over the life of the loan with payoff scheduled in 2021. The Board took his advice under consideration.

A motion was made by Commissioner Hilderbrand to amend the Agenda for Debbie Fox of the Neosho Township from 2:15 PM to 2:10 PM. It was seconded by Commissioner Collins. The motion carried 3-0 with all voting yes.

Debbie Fox - Neosho Township Treasurer

Debbie appeared before the Board for instructions on what to do next now that the Clerk and Trustee of the Neosho Township have resigned. The Board advised her to have anyone interested in filling the vacancies to submit a letter of request to the Board for consideration.

Sandy Friend - Shawnee Township

Sandy appeared before the Board to inform them the Crestline School is no longer going to be covered for damages by their insurance company. They are dropping them due to the extent of the termite damage in the school that has caused the building to be unsafe. She informed the Board that a decision would need to be made soon as to the fate of the old school.

A motion was made by Commissioner Collins to enter into an Executive Session for the purpose Non/Elected Personnel for a period of 10 minutes. It was second by Commissioner Napier. The motion carried 3-0 with all voting yes at 2:43 PM.

Meeting reconvened at 2:55 PM with no action taken as a result of the executive session.

A motion was made by Commissioner Hilderbrand to amend Resolution 09-2013 where it states "whereas on this 1st day of April" to read "whereas on this 8th day of April". It was second by Commissioner Collins. The motion carried 3-0 with all voting yes.



Commissioner Hilderbrand made a motion to adjourn until the next regularly scheduled meeting set for April 15th, 2013. It was second by Commissioner Collins and the motion carried 3-0. The motion passed at 3:26 PM.

RESOLUTION NO. 9 - 2013

A RESOLUTION SETTING THE COMPOSITION OF THE BOARD OF DIRECTORS OF FIRE DISTRICT NO. 1, COUNTY OF CHEROKEE, KANSAS, LOCATED IN LOLA TOWNSHIP; AND, DESIGNATING THE POWERS TRANSFERRED TO SUCH BOARD FROM THE BOARD OF COUNTY COMMISSIONERS OF CHEROKEE COUNTY, KANSAS.

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CHEROKEE COUNTY, KANSAS:

WHEREAS, the County in the form of its duly elected governing body has the authority under K.S.A. § 19-3601, et seq to organize one or more fire districts and has previously created Fire District No. 1, County of Cherokee, Kansas; and,

WHEREAS, K.S.A. 19-3612a provides that whenever the Board of County Commissioners shall determine that it is in the best interests of the county to place the supervision of such fire district under a fire district Board of Trustees, the Board may appoint a Board of Trustees of not less than three members and not more than nine members, who shall serve at the pleasure of the Board of County Commissioners; and,

WHEREAS, the Board of County Commissioners determines it is in the best interests of the county to appoint a five person Board of Directors to so supervise the fire district; and,

WHEREAS, the Board of County Commissioners may delegate such supervisory powers over Fire District No. 1, County of Cherokee, Kansas, as it shall deem advisable, to the Board of Directors of the fire district; and,

WHEREAS, it is appropriate to designate such powers as are set forth below.

WHEREAS, the Board of County Commissioners of Cherokee County, Kansas, (hereinafter designated "Board") meeting in regular session, this Xst day of April, 2013, does hereby resolve as follows:

<u>Section 1.</u> Fire District No. 1, County of Cherokee, Kansas, Board of Directors. The membership of the Board of Directors of Fire District No. 1, County of Cherokee, Kansas, (herein designated "Board of Directors"), shall be five members.

Section 2. Membership; Appointment; Removal. The members of the Board of Directors shall be appointed by the Board of County Commissioners. The members of the Board of Directors shall be appointed to serve for two year terms that expire on the 31st day of January of every odd-numbered year. Vacancies shall be filled by appointment by the Board of County Commissioners for the unexpired term only. The Board of County Commissioners, in its sole discretion, may remove any member of the Board of Directors at any time. Members of the Board of Directors shall serve without compensation. The positions on the Board of Directors shall be designated as Position #1 through Position #5.

Section 3. Meetings; Records; Budgets. The members of the Board of Directors shall meet at least annually, and at such other times as they may designate in their bylaws. The Board of Directors shall cause a proper record to be kept of its proceedings and regularly and promptly forward copies thereof to the County Clerk of Cherokee County, Kansas. The Board of Directors shall annually timely provide a budget and quarterly provide reports of its expenditures to the Board of County Commissioners.

Section 4. Powers and Duties. The Board of Directors shall have only those powers and duties set forth in K.S.A. 19-3601a(a)(b)(c)(d)(f)(g)(i) and (j), as well as the power to create and adopt bylaws. The Board of Directors shall not have the power to exercise eminent domain or the power to issue bonds. All expenditures of the fire district shall remain within the budgeting therefore by the Board of County Commissioners.

<u>Section 5.</u> Budget. The Board of County Commissioners, after consultation with the Board of Directors, or its designee, shall approve a budget for the fire district and establish a mill levy within the district to pay for the operations of the fire district, not to exceed 5 mills.

<u>Section 6.</u> Severability. If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this resolution, or the application thereof to any circumstances, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this resolution.

<u>Section 7.</u> **Publication.** This resolution shall be published once in the official county newspaper.
