MINUTES FOR NOVEMBER 12, 2010

The Cherokee Commissioners met November 12, 2010 to certify the recount and certify the election of Doug Gatewood as the official winner for the State of Kansas First District State Representative. Commissioners Hilderbrand, Collins and Garner were present, as well as Cherokee County Election Officer Crystal Gatewood, Cherokee County Clerk Deputy Paula Cheney, Cherokee County Attorney John Bullard, and candidate Doug Gatewood.

Election Officer Gatewood reported that 5,805 ballots had been hand counted, the totals were Michael Houser 2,828 the same as reported November 5, 2010, Doug Gatewood's total after recount was a 2,907, an additional 2 votes due to 2 over votes being decided by the Special Election Board as the voter's intent to vote for Gatewood. Gatewood's official count on November 5, 2010 was 2,905 votes. The special recount found 6 write-in votes and 64 under votes.

Commissioner Hilderbrand made a motion to certify the final results brought before the board from the recount held November 9, 2010. Doug Gatewood was the certified winner for the First District Kansas House State Representative Office with 2,907 ballots cast for Gatewood, over candidate Michael Houser, Houser's total was 2,828. Commissioner Hilderbrand's motion was seconded by Commissioner Garner, and all three commissioners voted in favor. Those signing the Official Certification were: Commissioners' Garner, Hilderbrand, and Collins, County Election Officer Crystal Gatewood, County Deputy Clerk Paula Cheney, and County Attorney John Bullard.

Commissioner Hilderbrand made a motion to adjourn at 9:30 AM, his motion was seconded by Commissioner Garner and all three commissioners voted in favor.
