MINUTES FOR AUGUST 16, 2012

COLUMBUS, KANSAS, CHEROKEE COUNTY

The Cherokee County Commissioners met for a Special Meeting to canvass the 2012 Primary Election held on August 7, 2012. The canvass started at 3:30 PM as scheduled. Those present were Commissioners Garner, Collins and Hilderbrand, Clerk Gatewood, Deputy Cheney, and County Counselor Cure. The pledge was said by all present. The group had 88 Provisional Ballots from the election to process by the commission. The commission agreed that 60 ballots would be counted and 28 ballots would not be counted. During the canvassing the County Counselor asked for the provisional ballots to have what ballot was in the provisional envelope.

The results were certified as presented after all of the provisional ballots were added to the totals from the unofficial count done on the August 7, 2012 Primary Election Results. Commissioner Garner made a motion to approve the final results of the Intermediate Canvass for the election held on August 7, 2012; his motion was seconded by Commissioner Collins with Commissioners Collins and Garner voting in favor, and Commissioner Hilderbrand voting no, stating he wasn't comfortable putting his signature on the integrity and accuracy of the election for the following reasons - the lack of information on the provisional ballots, the County Clerk filling in the numbers on the official receipts a week after the election, and the numbers not coming up accurate after the first final tally because of the M100 not counting 60 provisional votes. Also, after the second final tally, the numbers from the poll books and the final vote being off a second time, this time by a count of 144 ballots. After this, numbers only matched after the Clerk said she made an error in the poll book numbers. After the third adjustment of numbers, the poll book matched 100%. Those signing off on the documentation were Commissioners Garner and Collins, County Clerk Gatewood, Deputy Paula Cheney, and County Counselor Cure. Commissioner Hilderbrand made a motion to add to the documentation that he had concerns of the Clerk not having all of the receipts on the ballots to each polling place filled out on election night, and the Clerk filling these receipts in a week later; his motion was seconded by Commissioner Collins with Commissioners Collins, Hilderbrand, and Garner voting in favor. When all votes were tallied for the 2012 Primary Election held August 7, 2012, the numbers were as follows: Provisional - 60, Early Voter - 116, Advance - 469, and Election Day Total - 3,509. The total ballots cast were 4,154.

A copy of the Official Primary Results Summary is attached to these minutes. A copy of the Certification Document Signed by the Commission, Clerk, Deputy Clerk, and County Counselor are also attached to these minutes.



ADJOURNMENT

Commissioner Hilderbrand made a motion to adjourn at 9:15 PM; his motion was seconded by Commissioner Collins with Commissioners Garner, Collins, and Hilderbrand voting in favor. The next regular Cherokee County Commission meeting will be held Monday, August 20, 2012 at 9:00 AM in the Cherokee County Courthouse.

The results of the Primary Election held August 7, 2012 are certified as accurate and true after the canvassing of the results. The Board of Cherokee County Commissioners consisted of Commissioners Jack Garner, Pat Collins, Richard Hilderbrand, and under the consultation with County Counselor Kevin Cure, have determined that 88 Provisional Ballots were deemed reviewed. The final results were; of the provisional's, 5 partial ballots, 55 ballots counted and 28 ballots were not deemed qualified after further review.

The approved provisionals by the Canvassing Board were added to the vote count in their respective precinct in Cherokee County by Cherokee County Election Officer Crystal Gatewood on August 16, 2012. The document containing the final results was then submitted to the Commission on Thursday, August 16, 2012 for signatures by the Cherokee County Board of Commissioners and County Counselor Kevin Cure.
